- **6.** The Bundelkhand Academic Council will not change its address or shift the premises without prior permission in writing from the Organisation.
- 7. Bundelkhand Academic Council owner or its authorized representative shall be required to attend district level, regional and state level meetings from time to time as may be conducted by the Organisation (Bundelkhand Academic Council).
